- I am aware that e-Visa for incoming students provides only a Single-Entry Visa (SEV) for a single journey into Malaysia. Thus, passport submission is required on the first day of arrival at XMUM to apply for a long-term pass, which will take approximately 4-8 weeks from the date of passport submission. During this period, arranging any travel or external examinations that require passport is not allowed.
- I am aware that after completion, cancellation of visa is required before returning to my home country. Thus, [3 weeks before the mobility programme end] passport submission is required to complete the visa cancellation process. During this period, any arrangements that require passport is not allowed. Failure to cancel the visa in accordance with the procedures will affect your record in the Malaysian Immigration Department.
  - I can enroll in XMUM courses depending on availability; XMUM students have priority over mobility students.
  - I am aware that the acceptance of credit transfers depends on my home university/institution.
    - I am aware that English is the medium of instruction for all courses at XMUM, except for Traditional Chinese Medicine and Chinese Studies, proficiency in the language is essential for academic success to obtain credits.
      - I am responsible to check with my home university/institution to be certain that courses I take at XMUM will be accepted for credit transfer.
- I am responsible to check if I meet the prerequisites for any courses I want to take at XMUM.
- I understand that I am expected to attend classes regularly, unless otherwise indicated by illness or unavoidable circumstances.
